In addition, there were 20,346 volunteer service hours reported. These hours represent a minimum of \$162,768 of giving.

In the aftermath of hurricane Harvey, the love and generosity of St. Timothy was truly shown! Immediately our people stepped up to help our own members and our community with recovery efforts. Thousands of hours were spent clearing out homes, moving debris, washing clothes, and making meals for those affected. The work went on as our members continued to help those affected by the flooding by installing insulation and sheetrock in addition to all of the labor approximately \$100,000 was given and distributed to help those rebuilding. 


This doesn't include food, school supplies, toys, clothing, and the many supplies and other non-monetary donations that are given throughout the year.

Statement of Faith: At my confirmation, it was the practice of St. John's Lutheran Church to present a new Bible to each of its new confirmands. In each Bible, the pastor would write the confirmand's name, the confirmation date, and would write the reference to several Bible passages. Each confirmand received a unique set of Bible passages that the pastor believed to be important and significant to that confirmand. The very first reference he wrote in my Bible was Psalms 1.
